Description

Professional Line Mr. Clean All Purpose Cleaner is a lemon scented, chartreuse (light yellow/green) liquid cleaner designed for floors, kitchens and bathrooms.

Ingredients

Professional Line Mr. Clean is an aqueous solution of cleaning agents (anionic surfactant and butyldiglycol), water softening agents, quality control agents, colorants, and perfume.

Packaging

Professional Line Mr. Clean is packaged in 28 fluid ounce plastic bottles, 12 per case, and in 1 gallon plastic jugs, 3 per case.

Performance

Professional Line Mr. Clean All Purpose Cleaner can be used full strength or diluted for high quality cleaning without leaving dulling films or streaks. When used in diluted form (1/4 cup of Mr. Clean per gallon of warm water), there is usually no need to rinse. Mr. Clean is recommended for virtually all hard surface cleaning, especially waxed (non-quarry tile) floors.
